Dear Chairman Grassley:

The undersigned members of the Consortium for Citizens with Disabilities' (CCD) Developmental Disabilities Autism and Family Support Task Force, Financial Security and Poverty Task Force, and allied organization write to thank you and the Senate Finance Committee for your work to include a provision in the "American Workers, Families, and Employers Assistance Act"<sup>1</sup> that would ensure parents and caretakers of adult dependents receive \$500 dependent rebates. People with disabilities and older adults have been devastated by the COVID-19 pandemic. Many of them are at greater risk of harm from COVID-19 and have lost their community and health supports. This provision will help alleviate the increasing financial burden faced by many families caring for dependents with disabilities and older relatives and thus we strongly support the inclusion of this provision in the final version of the next COVID-19 relief bill.

We thank Congress for recognizing in the bipartisan Coronavirus Aid, Relief, and Economic Security (CARES) Act (P.L. 116-136) the dire financial situation faced by families as a result of the pandemic. The CARES Act addressed this issue by providing important economic impact payments to individuals and dependent rebates for children younger than 17. Unfortunately, the definition used by the CARES Act for "dependent" was not aligned with the definition of "dependent" under 26 U.S.C § 152 of the federal tax code, thereby excluding adult dependents (many of whom have disabilities) and their parents and caretakers from the recovery rebates. Those who were left out include parents with adult children living with a variety of conditions such as Down syndrome, autism spectrum disorder, spinal cord injury, and bipolar disorder. It also excluded many adult children who provide the majority of the financial support for their elderly parents.

These taxpayers included in the American Workers, Families, and Employers Assistance Act are among the fifty-three million family caregivers who provide the vast majority of our nation's long-term services and supports, permitting individuals of all ages to remain in their communities and avoid or delay more costly out-of-home

placements<sup>2</sup>. As the pandemic continues to run its course with no end in sight, it is absolutely critical that these families and their dependents receive direct financial support in the next COVID-19 relief bill.

Again, we thank you and the Committee for the inclusion of this important provision that would ensure parents and caretakers of dependent adult children with disabilities or other adult dependents receive recovery rebates and urge that it be included in any final version of the next COVID-19 relief bill. We look forward to working with you and the Committee on this important issue.
